**TRADE NOTICE NO.43/2007**

**Sub:- Implementation of Right to Information Act, 2005 – Designation of Central Public Information Officers (CPIOs) and Appellate Authorities within the jurisdiction of Central Excise & Customs, Surat-I Commissionerate – Regarding.**

Attention of all the Trade Associations/Chambers of Commerce and Public at large is invited to the Trade Notice No.31/2005 dtd. 11-07-2005 as amended by Trade Notice No. 35/2007 dtd. 10-10-2007 issued by this office vide which the information regarding Central Public Information Officers/Central Assistant Public Information Officers working in this Commissionerate was publicized/amended from time to time.

On account of change of the structure of Central Public Information Officers (CPIOs)/Appellate Authorities under the Right to Information Act, 2005 by the Central Board of Excise & Customs, New Delhi, a need has arisen to redesignate/appoint CPIOs/Appellate Authorities under the said Act. Accordingly, in partial modification of the above mentioned Trade Notice, a revised list of CPIOs/Appellate Authorities in respect of Central Excise & Customs Commissionerate, Surat-I is attached to this Trade Notice.

This Trade Notice shall come into effect on 01-12-2007. All RTI applications received (and appeals relating thereto) on or after this date i.e. 01-12-2007 shall be dealt with by the newly designated CPIOs/Appellate Authorities as specified in the Annexure attached to this Trade Notice.

All the Trade Associations/Chamber of Commerce are requested to publicise the contents of this Trade Notice amongst their Members/Constituents, for their information and necessary action. They are further requested to send their applications under RTI Act, 2005 to the newly designated CPIOs only – with effect from 01-12-2007 and not to the Commissioner of Central Excise & Customs, Surat-I.

They are further informed that the requisite application fee for seeking information under RTI Act, 2005 as prescribed vide the Right to Information (Regulation of Fee & Cost) Rules, 2005, as amended can be paid by way of Cash to the concerned CPIO against proper receipt or by Demand Draft/bankers Cheque/Indian Postal Order which should be made payable to the following Accounts Officers in respect of the concerned CPIO and should accompany the application.
